The project in brief (pitch)

The forests of the Rungwa River Forest Reserve and the Northern and Southern Corridors are subject to human pressures that threaten the ecosystems and resources they harbor, while the communities depend on them for their livelihoods. The aim of the project is to include neighboring villages in the management of the Rungwa River Forest Reserve, to formalize the existence of the corridors and to support added-value chains such as beekeeping, wild mushroom picking and extensive pastoralism throughout the region.

Background to the project

The Rungwa River Forest Reserve (2,100 km²), the Southern Corridor (950 km²) and the Northern Corridor (850 km²) link Ruaha and Katavi national parks. These areas are subject to intense human pressure for timber, bushmeat, grazing and land. The communities living adjacent to Rungwa River Forest Reserve are not involved in its management, even though they are subject to its restrictions. The Northern and Southern corridors on village land need the completion of their land use plans to be legally recognized and become a management unit. At the same time, products such as honey and wild mushrooms are under-valued and their added value is not created by local producers but by businessmen from the main cities.

Planned approach to the problem

The project plans to support a *Joint Forest Management* process to involve 4 riverside villages in the management of the Rungwa River Forest Reserve. It will also finalize the land-use planning process for the villages that contribute to the Northern and Southern corridors. The project also plans to support the development of the beekeeping and wild mushroom sectors in order to improve the quality and increase the quantity of products, which will enable communities in 16 villages to generate income from the forests without clearing them. Finally, the project will provide ways of mitigating the effects of intensive pastoralism in the region and will train primary school pupils in agro-ecology.

Objectives

The co-management documents for the Rungwa River reserve and land-use planning for the Northern and Southern Corridors are submitted to the government.

Producers in the 16 villages can sell their products through an association that certifies them, and have access to equipment and know-how to improve quality.

Young people, women and livestock farmers are more involved in developing and protecting forest resources.
